

AN ACT

To appropriate the sum of \$85,700 from the General Fund of the Federated States of Micronesia for the purpose of supplementing funds appropriated by Public Law No. 1-118, as amended by Public Law No. 1-125, for the operations of the executive branch, national judiciary, Public Auditor, and other programs of the National Government of the Federated States of Micronesia for Fiscal Year 1981, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 1-118, as amended by Public
2 Law No. 1-125, is hereby further amended to read as follows:

3 "Section 1. The sum of \$2,314,700, or so much thereof as may be
4 necessary, is hereby appropriated from the General Fund of the
5 Federated States of Micronesia for the executive branch, national
6 judiciary, Public Auditor, and other programs of the National
7 Government of the Federated States of Micronesia for Fiscal Year
8 1981. The sum appropriated by this act shall be apportioned as
9 follows:


