

AN ACT

To further amend section 2 of Public Law No. 4-17, Kosrae State public projects, as amended by Public Law No. 4-47, for the purpose of reapportioning funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 4-17, as amended by Public  
2 Law No. 4-47, is hereby further amended to read as follows:


